REGISTRATION

the Website and participate be eliaible to use in procurement opportunities, Supplier must register and provide all information required by the MFA, including, but not limited to, banking information. SUPPLIER ACCOUNT

Supplier will be issued a user ID and password (which must be changed upon initial login) after registering to establish a supplier account. Supplier may authorize its employees to use its account, but Supplier shall be responsible for all activities by such employees.
